

Kishwaukee College American Rescue Plan
Higher Education Emergency Relief Fund (HEERF II)
Student Disbursement Report

March 31, 2022

The Higher Education Emergency Relief Fund III (HEERF III) is authorized by the American Rescue Plan (ARP), Public Law 116-137, signed into law on March 11, 2021, providing \$39.6 billion in support to institutions of higher education to serve students and ensure learning continues during the COVID-19 pandemic. ARP funds are in addition to funds authorized by the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA), Public Law 116-260 and the Coronavirus Aid, Recovery, and Economic Security (CARES) Act, Public Law 116-136. Emergency funds available to institutions and their students under emergency funds total \$76.2 billion.

- x The action to increase the CRRSAA Higher Education Emergency Relief Fund II (HEERF II) grant award for Kishwaukee College as approved by Michelle Coopeon May 12, 2021. It is on this date that Kishwaukee College gained access to eeeer(to)2ed(da)4 (n)10ti(o)2 (v)7 r s-n

- x The total amount of funds that the institution will receive, or has received under the American Rescue Plan Higher Education Emergency Relief Fund (HEERF II) student portion was \$2,961,416.
- x Of those funds, the total amount that has been distributed to students in the fall 2021 semester as of the date of reporting (i.e. the first 30 day deadline, and then every 45 days thereafter) as follows:
 - o \$1,844,080 was awarded by need and the need was determined by EFC. Students with 0 EFC were awarded by credit hour and billing type. The award amount per credit hour was \$150.00, \$225.00 and \$300.00 based on billing type of the course. Students with a greater than 0 EFC or did not complete a FAFSA were awarded \$75.00, \$112.50 or \$150.00 per credit hour based on billing type of the course.
 - o Kishwaukee College distributed to 1,816 students
- x Of those funds, the total amount that has been distributed to students in the spring 2022 semester as of the date of reporting (i.e., the first 30 day deadline, and then every 45 days thereafter) as follows:
 - o \$1,110,014.19 was awarded by need and the need was determined by EFC. Students with 0 EFC were awarded by credit hour and billing type. The award amount per credit hour was \$120.00, \$145.00, and \$195.00 based on billing type of the course. Students with a greater than 0 EFC or did not complete a FAFSA

- o Kishwaukee College distributed to 1495 students.
- x How the institution determined which students did or will receive emergency financial aid grants and how much funding they did/will receive.
 - o For the fall 2021 disbursement, Kishwaukee College distributed funding to all credit students based on number of credit hours enrolled and billing type for the courses as of September 13, 2021. Based on guidance provided by the Department of Education, students must meet the following eligibility parameters to qualify for American Rescue Plan funds: Be eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965, as amended. (e.g., be eligible to receive federal financial aid funds such as the Pell Grant, TEACH Grant, Direct Loans, etc.).
 - o For the spring 2022 disbursement, Kishwaukee College distributed funding to all credit students based on number of credit hours enrolled and billing type for the courses as of February 11, 2022. Based on guidance provided by the Department of Education, students must meet the following eligibility parameters to qualify for American Rescue Plan funds: Be eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965, as amended. (e.g., be eligible to receive federal financial aid funds such as Pell Grant, TEACH Grant, Direct Loans, etc.).

As part of the American Rescue Plan Act of 2021, colleges were instructed to notify students of the possibility to appeal their Free Application for Federal Student Aid (FAFSA) results if you or your family's financial situation has changed significantly from what is reflected on your federal income tax return used for the FAFSA, (for example, if you've lost a job or otherwise experienced a drop in income), you may be eligible to have your financial aid adjusted.
